Teaser	Would you like to work in Germany as a medical technologist for laboratory analysis or medical technologist for laboratory analysis? Then you need a state permit. For this purpose, you can have your foreign professional qualification recognized.

is regulated in Germany. This means that in order to be able to work in Germany as a medical technologist for laboratory analysis, you need a state permit. With the permit, you may use the professional title "Medical Technologist for Laboratory Analysis" or "Medical Technologist for Laboratory Analysis" and work in the profession.

Even with a professional qualification from the European Union (EU), the European Economic Area (EEA) or Switzerland, you can obtain state permission from the competent authority in Germany. In order to obtain the permit, you must have your foreign professional qualification recognized.

In the recognition procedure, the competent authority compares your professional qualification from abroad with the German professional qualification and checks its equivalence. The equivalence of the professional qualification is an important prerequisite for the issuance of the state permit.

In addition to the equivalence of the professional qualification, you must meet other requirements for the granting of the permit. Other requirements are, for example, sufficient German language skills and health suitability. If your professional qualification does not come from the EU, EEA or Switzerland, other regulations apply. You can also apply for the procedure from abroad.

Erforderliche Unterlagen

- Proof of identity (ID card or passport)
- Marriage certificate (if your name has changed due to marriage)
- Curriculum vitae
- Officially certified proof of your professional qualification (e.g. certificates, professional certificate)
- Officially certified copies of your educational qualifications (diploma, curriculum or curriculum with details of subjects and hours)
- Proof of your relevant professional experience as a medical technologist for laboratory analysis or medical technologist for laboratory analysis
- Proof of further relevant knowledge for working as a medical technologist for laboratory analysis or medical

- Declaration that you have not yet submitted an application for recognition
- Do you come from a third country and do not yet live or work in the EU, the EEA or Switzerland and want to work in the profession in Germany? Then you need to prove: Confirmation of employment from an employer or a corresponding employment contract, applications for a job, invitations to interviews, a business concept, or a location note from the Central Service Centre for Professional Recognition (ZSBA).

You usually hand in these documents later. The competent authority will inform you when you should hand in the documents:

- Proof of your personal suitability: for example, an extract from your criminal record or certificate of good conduct from your country of origin. The proof must be no more than 3 months old at the time of application.
- Proof of your health suitability: for example, a medical certificate. The proof must be no more than 3 months old at the time of application.
- Declaration of Your Reliability
- Proof of your German language skills

The competent authority will tell you which documents you need to submit as a simple copy, as a certified copy or in the original.

Voraussetzungen

- You have a professional qualification as a medical technologist for laboratory analysis or medical technologist for laboratory analysis from the EU, the EEA or Switzerland.
- You want to work in Germany as a medical technologist for laboratory analysis or medical technologist for laboratory analysis.
- Personal aptitude: You are reliable for working as a medical technologist for laboratory analysis or medical technologist for laboratory analysis and have no criminal record.
- Health suitability: You can work mentally and physically as a medical technologist for laboratory analysis or medical technologist for laboratory analysis.

Kosten	<p>The fees are based on the Administrative Costs Regulations plus expenses.</p> <p>Information on the fees can be found on the homepage via the link below.</p> <p>In addition, additional costs may arise (e.g. for translations, certifications or compensatory measures). These costs vary from person to person.</p>
Verfahrensablauf	<p>Application</p> <p>You submit an application for permission to use the professional title "Medical Technologist for Laboratory Analysis" or "Medical Technologist for Laboratory Analysis" to the competent authority. You can submit the application with the documents to the competent authority or send it by post. Do not send originals. It is also possible for you to submit the application to us electronically. It must be taken into account that the application documents and the printed application form must then be sent by post to the competent authority.</p> <p>Examination of equivalence</p> <p>The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent authority compares your professional qualification from abroad with the German professional qualification as a medical technologist for laboratory analysis. foreign professional qualification will be recognised. The competent authority can confirm the result to you in writing. You still have to meet the other requirements. Then you will receive permission to use the professional title "Medical Technologist for Laboratory Analysis" or "Medical Technologist for Laboratory Analysis".

Are there any significant differences between your professional qualification and the German professional qualification? Perhaps you can compensate for the differences through your professional practice, other knowledge or skills (lifelong learning). You must prove that you have professional experience. Knowledge and skills must be certified by an authority of the state in which you acquired the knowledge or skills.

However, it may be that the essential differences cannot be compensated for by this knowledge. In this case, the competent authority will tell you the main differences between your professional qualification and the German professional qualification. It also tells you why you can't make up for these key differences.

The competent authority will also provide you with compensatory measures that you can take to compensate for the significant differences. If you decide not to take compensatory measures, your professional qualification will not be recognised. In this case, they are not allowed to work in Germany as a medical technologist for laboratory analysis.

Compensatory measures

There are various compensatory measures:

- Adaptation period: The adaptation period lasts a maximum of three years.
- Aptitude test: In the aptitude test, only those areas in which significant differences have been identified are examined. The aptitude test is a practical exam with exam interviews.

As a rule, you can choose between an adaptation period or an aptitude test.

If you successfully complete the compensatory measure and meet all other requirements, you will receive permission to use the professional title "Medical Technologist for Laboratory Analysis" or "Medical Technologist for Laboratory Analysis".

Bearbeitungsdauer

6 - 9 Monat(e)
 After a maximum of one month, the competent authority will confirm that your application and documents have arrived. The competent authority will inform you if documents are missing. If the documents are complete, the procedure can currently take between 6 and 9 months.

Frist

Sometimes documents are still missing in the procedure. The competent authority will then inform you by when you have to submit the documents.

Hinweise

Partial access to the profession for professional qualifications from the EU, the EEA or Switzerland

Your professional qualification is not equivalent and the differences are too great? Then you may be able to work in the profession with a partial access to the profession. With partial access to the profession, you can also work in the profession without recognition. There are certain prerequisites for this. Your professional qualification must include at least one so-called reserved activity of the German professional qualification. Reserved activities may only be carried

out by specially trained persons. You must also prove that you are personally suitable, fit in health and have the necessary knowledge of German.

With partial access to the profession, you are only allowed to take on certain tasks as a medical technologist for laboratory analysis or medical technologist for laboratory analysis. You can apply for partial access to the profession at the competent authority.

Freedom to provide services

Would you like to offer services only sometimes and for a short time in Germany? Then most of the time you don't need the state permit. You must meet these requirements:

- You must be established in another state of the EU, the EEA or Switzerland.
- You will need to prove your professional qualification.
- You must provide proof of German language proficiency at the required language level.
- You will need to prove your personal suitability.
- You must notify the competent authority of your activity in writing.

The competent authority will inform you whether you are allowed to provide services or whether you have to take an aptitude test.

Notice of equivalence

In the approval procedure, the equivalence is also checked (recognition procedure). You can apply for a separate notification for the result of the examination.

Procedure for ethnic German repatriates

As a late repatriate, you can go through the recognition procedure either according to the laws mentioned here or according to the Federal Expellees Act. You can decide for yourself. The competent authority will advise you on which procedure is right for you.
