Voraussetzungen	<p>Approval for change shall be granted if:</p> <ul style="list-style-type: none"> <li>• it is ensured that the obligations arising from the requirements of the Federal Immission Control Act and the Federal Immission Control Ordinance are fulfilled and</li> <li>• other public law regulations and occupational health and safety concerns do not conflict with the construction and operation of the plant.</li> </ul>

Verfahrensablauf	<p>The approval procedure requires a written or electronic application, which must be accompanied by the drawings, explanations and other documents required to check the approval requirements.</p> <p>If the application is complete, it must be made public together with the documents and then displayed for one month.
