Volltext	If you wish to hunt in Germany, you will need a German hunting license in your name. If your annual hunting license for foreign youngsters has been revoked, you can reapply for it at the authority that revoked your hunting license after the expiry of the specified retention period.

The application and the supporting documents to be provided will be checked for completeness and correctness.

If you meet all the requirements, you will be issued with a youth hunting license for foreigners.

The annual hunting license is valid for a maximum of three consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03..

- Youth hunting license for foreigners Re-issue of annual hunting license
 - required for hunting in Germany
 - Re-application required after withdrawal
 - Application only possible after expiry of the ban period
 - for persons under 18 years of age, minimum age 16 years
 - is valid for a maximum of 2 consecutive hunting years
 - Hunting year begins on 01.04. and ends on 31.03.
 - is reissued by the authority that revoked the hunting license
 - Responsible: lower hunting authority
