Erforderliche Unterlagen	• Medical certificate of fitness (not older than three months), • Certificate of good conduct according to § 30 paragraph 4 of the Federal Central Register Act (not older than three months), • Declaration of reliability
Voraussetzungen	• You have completed the prescribed training and passed the state examination, • You have not been guilty of any behavior that would make you unreliable to practice the profession, • You are not medically unfit to practise the profession, • You have the knowledge of the German language required for practicing the profession
