The test experts for technical installations and facilities in buildings certify the conformity of the technical systems and facilities to be tested with the requirements of building regulations after carrying out

	their own inspection. If any defects found are not remedied within the time limit set by the inspection experts, they must inform the lower building supervisory authority.
