| Volltext                      | If, as a foreign person, you are subject to the residence obligation for a certain place, you can, under certain conditions, have this residence obligation lifted or changed if you wish to move to another federal state. To do this, you must submit a corresponding application to the responsible immigration authority.   |
| Erforderliche Unterlagen      | <p>The required documents always refer to the particular reason for the request to move. The prerequisites must be proven. The requirements can also be fulfilled by a family member of the applicant. - Apprenticeship or university place

- The person in a marriage with you, your registered civil partnership or the minor child lives in another place of residence

- Avoidance of hardship (e.g. humanitarian reasons)

- Other foreign person who is subject to a residence requirement An income that secures your livelihood

- Training or study place

- The person in a marriage with you, your registered civil partnership or the minor child lives at another place of residence

- Other humanitarian reasons

- Responsible: Foreigners authority or immigration authority of the respective place of residence.
