Teaser	Would you like to use your deregistered vehicle on the road again? Then you can re-register it with the registration authority.
Volltext	If you want to use your deregistered vehicle on the road again, you must first re-register it.  This is a re-registration to the same owner if you are the person who was previously registered as the owner of the vehicle. If there has been a change of keeper, this is referred to as re-registration to a different keeper.  You can submit the application in person to the registration authority responsible for you or appoint a representative to do so.

If necessary, the following must also be submitted:

If you wish to use a new license plate:

- Registration certificate part II (vehicle registration document)
- if already available: new (desired) license plate reserved in advance including PIN

If you are represented by a third party or a third party:

• Written power of attorney and original identification document of the holder; the authorized person himself must be able to identify himself with his valid identity card or passport.

In the case of re-registration for minors:

• the written declaration of consent of the legal guardians and their original identity cards; if applicable, a certificate of sole custody ("negative certificate") in the case of single parents

Depending on the individual case, the licensing authority may request further or other proof from you.

## Voraussetzungen

- The vehicle is currently not in use.
- There has been no change of owner.
- You must not have any outstanding fees and expenses from previous registration processes of more than EUR 30.
- You must not have any vehicle tax debts of EUR 5 or more. This also includes late payment penalties, interest and late payment penalties.
