They will provide you with details on the type and scope of the necessary investigations. • You evaluate the continuous measurements of the respective calendar year. • You prepare a measurement report on the results. • You can commission an accredited measuring institute or an expert to evaluate the continuous measurements or prepare the measurement report.

Frist	You must submit the measurements and measurement report together with all documents to the responsible immission control authority within the period specified in the approval notice for your installation. You must keep the measurement report and the records of the measuring devices for at least 5 years after the end of the respective reporting period.
