| Teaser                           | If you live in Germany and have suffered a health<br>impairment during a temporary stay abroad, you may<br>receive a one-off payment depending on the degree of<br>your injury. You can find out more about this here.   |
| Volltext                         | If you live in Germany and have been the victim of an<br>act of violence during a temporary stay abroad and<br>have suffered damage to your health, you can receive<br>a one-off payment of between EUR 2,719 and EUR<br>29,907. The amount of the one-off payment depends<br>on your degree of injury (GdS at least 30).<br>A stay abroad is considered temporary if it lasts less<br>than six months or no more than one year if you are<br>attending school or university.<br>Please note that your social compensation provider will<br>decide whether and to what extent you will receive<br>support. |
| Erforderliche Unterlagen         | If necessary, you must provide evidence:<br>• Proof of the recognized harmful event during a<br>temporary stay abroad (e.g. police reports, court<br>decisions, court rulings, witness statements)<br>• Proof of the degree of the consequences of the injury<br>(e.g. medical certificates)   |
| Voraussetzungen                  | <ul> <li>You have your domicile or habitual residence in<br/>Germany.</li> <li>You were temporarily abroad at the time of the crime<br/>and suffered a recognized harmful event there.</li> <li>You have suffered damage to your health with a</li> </ul>  |

| Verfahrensablauf | When you apply for social compensation benefits, the<br>social compensation law institution will check whether<br>you are entitled to the one-off payment for victims of<br>violence abroad . You will receive a notification of the<br>decision and, if applicable, information on the benefits<br>granted as well as other necessary evidence.  |
|                  | You can apply for social compensation benefits online or in writing.  |
|                  | • If necessary, you can make an appointment with your contact person at the pension authority or at your responsible office.  |
|                  | <ul> <li>They will then discuss with you whether you are<br/>entitled to social compensation benefits and what<br/>support services can be offered.</li> </ul>  |
|                  | <ul> <li>If necessary, the case management team can discuss<br/>the further procedure and possible entitlements to<br/>benefits with you that go beyond the general duty to<br/>provide information and advice.</li> </ul>  |
|                  | <ul> <li>If you are entitled to social compensation benefits,<br/>your contact person will discuss the next steps with<br/>you.</li> </ul>  |
|                  | <ul> <li>The contact person will provide you with the relevant<br/>documents. If necessary, complete the documents,<br/>enclose the required evidence or supporting<br/>documents and send the documents back to your<br/>contact person.</li> </ul>  |
|                  | • Your claims will be determined ex officio on the basis<br>of the documents. The authority will inform you of the<br>result in the form of a decision, which is usually sent to<br>you by letter.  |
|                  | <ul> <li>If entitlements to benefits have been determined, you will receive an approval notice. If no entitlements are determined, you will receive a rejection notice.</li> <li>You also have the option of submitting the application online. To do this, you must complete the online application and upload the necessary supporting documents.</li> <li>The eligible costs and approved cash benefits will be</li> </ul> |
