Volltext	<p>Are you in a difficult life situation and having problems finding a job or training place or applying for citizen's benefit?</p> <p>If you have several of the difficulties listed below, you may be eligible for support:</p> <ul style="list-style-type: none"> <li>• no school-leaving certificate</li> <li>• No job or training place</li> <li>• You are demotivated by failures and do not feel resilient</li> <li>• You are threatened with homelessness or are already homeless</li> <li>• Family conflicts</li> <li>• difficult biographical histories, for example if you grew up in a foster family, a residential group or in families with entrenched long-term unemployment</li> <li>• Financial problems or debts</li> <li>• Health problems or addiction problems</li> </ul> <p>For example, you can receive the following support as part of the funding:</p> <ul style="list-style-type: none"> <li>• Help with stabilizing your financial situation</li> <li>• Support in applying for social benefits, such as citizen's allowance</li> <li>• Help with finding accommodation or stabilizing your housing situation</li> <li>• Assistance with visits to the authorities</li> <li>• Support with the organization of necessary treatments</li> <li>• Help with building up social networks</li> <li>• Support in developing new career prospects</li> </ul>

Voraussetzungen	<p>You can claim support within the framework of the funding if you</p> <ul style="list-style-type: none"> <li>• are between 15 and under 25 years old, and</li> <li>• are entitled or likely to be entitled to citizen's allowance, and</li> </ul> <p>have difficulties due to their individual situation</p> <ul style="list-style-type: none"> <li>• complete a school, training-related or vocational qualification or otherwise start working life and</li> <li>• apply for or accept social benefits.</li> </ul>
Kosten	There are no costs.
Verfahrensablauf	<p>If you need support, you can get advice from your job center.</p> <ul style="list-style-type: none"> <li>• Contact your local job center for support.</li> <li>• If funding is possible, they will put you in touch with the responsible organization.</li> <li>• If you are already in contact with the provider, they may be able to help you contact the job center and clarify the eligibility requirements.</li> </ul>
