Volltext	<p>New and amended land use plans are generally available online. If this is not the case for a land use plan, you can request information about its contents if you wish to view it. The local authority responsible for the local municipality or the body responsible for the procedure is obliged to provide you with the requested information.</p> <p>A land use plan</p> <ul style="list-style-type: none"> • is a preparatory urban land-use plan and the basis for a development plan. • It has no legally binding significance. The intended urban development of a municipality is defined in the land use plan. The plan therefore shows how each part of the municipal area is to be used. <p>Possible uses are</p> <ul style="list-style-type: none"> • Residential, • commercial, • transportation, • infrastructure, • recreation or • nature and the environment. <p>It generally consists of:</p> <ul style="list-style-type: none"> • Indication of the planning objectives • various maps on land use, development or the environment • a legend to the maps and

Kurztext	<ul style="list-style-type: none"> • Land use plan information • Get information on the content of a land use plan • Land use plan is a preparatory urban land-use plan and the basis for a development plan has no legally binding significance • the land use plan defines the intended urban development of a municipality, i.e. how each part of the municipal area is to be used • Possible uses are Residential, commercial, transportation, infrastructure, recreation or nature and the environment • The responsible authority or process owner is obliged to provide information • amended and new land use plans are made available on the Internet • If it is an older land use plan, it may be necessary to apply for access first

- An informal request for information can be made
- depending on the local authority responsible, the application can be submitted by post, online or by email
- The application is free of charge
- The land use plan generally consists of Indication of the planning objectives, various maps on land use, development or the environment, Legend to the maps Justification with, for example, details of decisions and considerations
- Responsible: local authority in which the area described in the land use plan is located
