	§29 (10) StVZO and submitted to the registration authority whenever the vehicle documents are dealt with. If the vehicle is passed on (e.g. sale, donation), it must be handed over to the purchaser. If you have lost or misplaced your HU test report, you are obliged to either obtain a duplicate (from the institution that carried out the HU) or you must have a new HU carried out at your own expense. The inspection sticker on the license plate or the HU stamp in the vehicle registration document alone are not sufficient proof of a valid main inspection.
