Voraussetzungen	The traffic measures required to make the work site safe must always be checked on a case-by-case basis. The contractor and the road traffic authority have access to the guidelines for securing work sites on roads (RSA) as well as standard plans for all possible safety measures. Those responsible for traffic safety and the operation and troubleshooting of any signal systems must provide evidence of the necessary specialist knowledge in accordance with the information sheet on the general conditions for the specialist knowledge required for traffic safety at road works (MVAS). The ordering authority may allow exceptions to this rule for work with a minor impact on traffic.
