Otherwise, the following persons are obliged to report a death in the following order</p> <ol style="list-style-type: none"> <li>1. Any person who lived with the deceased in the same household,</li> <li>2. the person in whose home the death occurred,</li> <li>3. any other person who was present at the death or who is aware of the death from their own knowledge. (This also includes the morticians, who usually take over the notification after the clinics).</li> </ol> |
