Volltext	Nationals of the Member States of the European Union and Switzerland, and of other signatory states to the Agreement on the European Economic Area, who are entitled to work independently as European lawyers, may, upon application, work in Germany as established lawyers under the professional title of their country of origin. To do so, they must be admitted to the bar association responsible for the place of establishment. Admission to the bar association requires that the applicant is registered as a European lawyer with the competent authority in the country of origin. After admission, the European lawyer is entitled to practice as a lawyer in Germany under the professional title of the country of origin. This also includes advising and representing clients in German law.
Erforderliche Unterlagen	• Application form "Application by a European lawyer for admission to the Bar" (original) • Questionnaire for the application form • Curriculum vitae with photograph • Proof of nationality • Certificate from the competent authority in the country of origin confirming membership of the profession of lawyer together with a certified translation (not older than 3 months) • Proof of professional liability insurance (original) • If applicable, certified copy of the doctoral certificate or other evidence of the acquisition of academic degrees • Transfer of the administrative fee
