Teaser	<p>If your livelihood is at risk as a result of a loss of earnings in accordance with Section 56 (1) or (1a) IfSG, you can apply for a certain amount of additional expenses to be reimbursed.</p>
Volltext	<p>The Infection Protection Act (IfSG) protects the population in Germany. It also provides financial compensation for people who are affected by the protective measures.</p> <p>If you are placed in domestic quarantine or banned from working as a result of an official measure under the Infection Protection Act and suffer a loss of earnings as a result, you are generally entitled to compensation for the loss of earnings incurred.</p> <p>In the event of a threat to their livelihood, those entitled to compensation may also be reimbursed by the competent authority to an appropriate extent for the additional expenses incurred during the loss of earnings.</p>

	<p>Payment and application are made in writing to the competent authority.</p> <p>The application for compensation must be submitted retroactively within 2 years of the start of the ban on work or the end of the quarantine.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Proof of existential risk</li> <li>• Proof of income (tax assessment notice) for the previous year</li> <li>• If available: Proof of loss of income during the period of the activity ban or isolation/quarantine</li> <li>• Proof of insurance benefits received, if applicable</li> <li>• If available: Proof of the official measure that caused the loss of earnings</li> </ul> <p>For authorized representatives:</p> <ul style="list-style-type: none"> <li>• If you are submitting this application on behalf of a company or a self-employed person (e.g. as a tax consultant), please submit a power of attorney.</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• There was a quarantine in accordance with Section 30 IfSG or a ban on work in accordance with Section 31 IfSG.</li> <li>• There was no possibility of compensating for the loss of earnings through another reasonable activity.</li> <li>• The livelihood of those affected is at risk and additional expenses have been incurred.</li> <li>• The application for compensation must be submitted within 2 years of the start of the ban on work or the end of the quarantine.</li> <li>• There was no illness or inability to work.</li> </ul>

Verfahrensablauf	<p>Applications must be submitted in writing to the competent authority.</p> <p>After the authority has examined the claim, a corresponding decision is issued.</p>
Bearbeitungsdauer	Applications are processed in the order in which they are received.
