Teaser	If you are a person in a healthcare profession who is not organized in a chamber and would like to exchange your defective electronic healthcare professional card (eHBA), you must contact your trust service provider.
Volltext	The electronic healthcare professional card (eHBA) enables people in the healthcare professions to access the telematics infrastructure (TI - the telematics infrastructure networks all participants in the healthcare system and will thus enable access to the electronic patient file (ePA), for example). If your eHBA is defective, you can exchange it with your trust service provider. You can only exchange your eHBA with the trust service provider from whom you received the card.
