Teaser	You can submit an application for recognition of your vocational training acquired abroad to the authority responsible for your profession.
Volltext	<p>Vocational training acquired and completed abroad or a course of study completed abroad can be recognized in Germany as equivalent to German training. However, this is a basic requirement for regulated professions such as doctor, teacher or nursery school teacher. The applicant only has unrestricted access to the profession they have learned once equivalence has been established by the competent authority.</p> <p>Professional recognition is the responsibility of different authorities. This depends on the profession in question. Background information on the individual professions in Germany as well as the respective responsibilities can be found on the portal <a href="http://www.anerkennung-in-deutschland.de">www.anerkennung-in-deutschland.de</a>.</p> <p>The prerequisite for the responsibility of an authority in North Rhine-Westphalia is either a residence in North Rhine-Westphalia, proof of a commitment to employment in North Rhine-Westphalia or a location note from the Central Office for Professional Recognition of the Federal Employment Agency (ZSBA) referring to North Rhine-Westphalia.</p>
Erforderliche Unterlagen	The documents required for an application vary depending on the profession. In any case, proof of completion of the respective vocational training or course of study is required in accordance with the legal framework of the country of training. This usually requires an official translation into German.

Kosten	<p>The cost framework for a professional recognition procedure varies depending on the profession. In addition to fees for the administrative procedure, there are also costs for translations and/or certifications. There may also be costs for expert opinions or equivalence checks. Persons residing abroad may have to pay costs for visas, residence permits and entry costs. In the context of any necessary adaptation qualifications, living expenses must also be covered for this period.</p>
Verfahrensablauf	<p>You can submit an application for recognition of your foreign professional qualification to the authority responsible for your profession in North Rhine-Westphalia. Bearbeitungsdauer	<p>Determination of equivalence: Up to 4 months after submission of all required documents.</p>
Frist	<p>Decision on the application within a maximum of 4 months from submission of all required documents to the competent authority.</p>

In North Rhine-Westphalia, the procedures for determining equivalence for healthcare professions with a license to practice and applications for a professional permit are processed centrally by the Münster district government.
