Teaser	Here you can find out how pupils can register online for admission to a vocational school (specialist class of the dual system) as part of dual vocational training.
Volltext	If you are starting dual vocational training, your training company will register you for vocational school. The vocational college you attend depends on the location of your training company and the respective profile of the vocational college. In order to fulfill the compulsory schooling requirement, the company providing the training is entitled to admit you to the vocational college closest to the company providing the training where a corresponding specialist class is set up. With the agreement of the training company, you have the option of attending another vocational college, in particular one that is closer to your place of residence.

Modul	Sachverhalt
	During your training in the vocational classes of the dual system, you will acquire the vocational school leaving certificate. At the same time, you have the opportunity to obtain a higher general school-leaving certificate (lower secondary level qualifications; entrance qualification for universities of applied sciences). The aim of the training is to acquire job-related and cross-occupational skills. The vocational schools and training companies are equal partners in dual vocational training. If you are under the age of 21 at the start of your training, you are required to attend school until the end of your training. The vocational school and the training companies jointly monitor compliance with your compulsory schooling. The school management decides on admission to a vocational school.

Voraussetzungen	Existence of a training contract for dual vocational training in accordance with the Vocational Training Act (BBiG) or another legitimate interest to be proven.

- Registration for vocational school (dual system vocational class).
- Registration by the training company with a valid training contract.
- Registration by the student in the case of full-time school-based training in accordance with the Vocational College Accounting and Admission Ordinance (BKAZVO) or in the case of admission to full-time school-based training at the Staatliche Glasfachschule Rheinbach.
- Every training company is entitled to have its trainees attend the vocational college nearest to the training company where a corresponding technical class is set up in order to fulfill their compulsory schooling. The vocational school (vocational class of the dual system) provides a vocational school certificate.
- Depending on previous education, a higher general qualification can also be obtained.
- The school management decides on admission to a vocational grammar school.
