Volltext	If you catch eels for commercial purposes, you must document every day you catch them. You can submit the annual report using the online service or send your records to the authorities by post. In your annual report, state the catch area, the catch weight of the eels, the percentage of silver eels as well as the type, number and deployment time of the fishing gear used. Does not apply in NRW!

- You are obliged to keep the documents for up to five years.
- The upper fisheries authority receives your records and checks them.
- If necessary, questions will be clarified with you directly.
- The annual report is then entered in the fishing register by the authority.
