Voraussetzungen	The applicant must use the aforementioned documents to demonstrate and, if necessary, prove that it is capable of operating an energy supply network on a permanent basis.
Kosten	The decision is subject to a fee of between €500 and €100,000.
Verfahrensablauf	The applicant must submit an informal application for a permit to operate an energy supply network to the energy supervisory authority. The above-mentioned documents must be attached; if they are incomplete, they can also be submitted subsequently. The energy supervisory authority first checks the application and the documents submitted for completeness and conclusiveness. It then contacts the applicant and discusses the next steps and procedure with them.
