| Volltext | If you would like to enrol at a university in North Rhine-Westphalia, a distinction must be made between admission-free and admission-restricted degree programs: You can enrol directly in admission-free degree programs with the required documents once you have met the necessary requirements, if necessary after submitting a previous application. There are only a limited number of places on degree courses with restricted admission, so a selection procedure takes place. A selection procedure generally takes place at universities of art and music. The following applies to degree programs with restricted admission: After a successful application for a study place, including a successful selection |
