Teaser	Are you no longer the owner of a dog? Then you must deregister it from the dog tax.
Volltext	<p>As a dog owner, you must deregister your dog from the dog tax in the following cases:</p> <ul style="list-style-type: none"> • Death of the animal, • loss of the animal, • Disposal of the animal (sale or giving away) • Surrender of the animal to an animal shelter • Moving to another city or municipality <p>The corresponding dog tax stamp for the deregistered dog must be handed in to the city or municipal administration.</p> <p>If the dog is successfully deregistered, you will receive a confirmation of deregistration or an amended tax assessment notice from the city or municipal administration. If you deregister in December, you will not receive these documents in some municipalities. In this case, no new notice will be issued.</p>

	The local tax authorities are responsible.
Erforderliche Unterlagen	<p>In the event of the dog's death:</p> <ul style="list-style-type: none"> • Certificate from the veterinarian or rendering plant <p>If the dog is given away or sold:</p> <ul style="list-style-type: none"> • Gift, transfer or purchase contract • Address of the new dog owner <p>In case of surrender to an animal shelter:</p> <ul style="list-style-type: none"> • Admission certificate from the animal shelter <p>If moving to/away from another town or municipality:</p> <ul style="list-style-type: none"> • Confirmation of change of address/registration <p>In any case, the dog tax stamp must be returned to the city/municipal administration.</p>

Hinweise	Irrespective of the deregistration of a dog under tax law, deregistration may also fall under the provisions of the Dog Law for the State of North Rhine-Westphalia (LHundG NRW).

A dog must be deregistered from the dog tax if:

- it dies
- it has gone missing
- it has been given away or sold
- it has been handed over to an animal shelter
- you move to another town or municipality

The corresponding dog tax stamp for the deregistered dog must be handed in to the city or municipal administration.
