Teaser	If you receive social welfare or basic income support and have just had a baby, the social welfare office will cover the cost of counseling sessions.
Volltext	During the first months and years of their child's life, many parents experience situations that make them feel insecure, worried or overwhelmed. The health assistance offers mothers and fathers advice on issues such as: • insatiable crying and frequent restlessness of the infant • difficulty falling asleep and staying asleep • Problems with breastfeeding, feeding and eating • Behavioral problems such as excessive anger and defiance, fearfulness or aggressiveness, unwillingness to play • separation anxiety and difficulties • Tense family situation • relationship problems • excessive demands, insecurity and exhaustion • postpartum depression
Erforderliche Unterlagen	• Application for health assistance • Identity card or passport (or other documents that can identify the person beyond doubt). The competent social welfare institution will provide information on the documents required in individual cases.
