Volltext	<p>You have an obligation to notify the authorities,</p> <ul style="list-style-type: none"> • if the rent/charge (excluding heating costs) is reduced by more than 15 percent, • if the income of the household members increases by more than 15 percent, • if the number of household members decreases, • if one or more household members apply for or receive transfer benefits (unemployment benefit II, social benefit, basic income support), • if a single household member dies (notification by the heirs or guardians). <p>The changes can lead to a reduction or, if necessary, to the complete elimination of housing benefit.</p> <p>If you are already receiving housing benefit, you can submit a new application for higher housing benefit,</p> <ul style="list-style-type: none"> • if your total income has decreased, • the number of household members to be taken into account has increased or • your rent or housing costs have increased. <p>These changes can, but do not necessarily have to, lead to an increase in housing benefit.</p>

	<p>If you are already receiving housing benefit, you can submit a new application for higher housing benefit,</p> <ul style="list-style-type: none"> • if your total income has decreased, • the number of household members to be taken into account has increased or • your rent or housing costs have increased.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Proof of income (salary certificate, pension certificate) • rental agreement • Documents on the costs of the residential property you use, if you are the owner • Proof of receipt of transfer payments, if you receive these (unemployment benefit II, social benefit, basic income support)
Voraussetzungen	<p>Prerequisites for an increase in housing benefit are</p> <ul style="list-style-type: none"> • a reduction in income of more than 15%, • an increase in the number of household members • an increase of more than 15% in the rent or the cost of home ownership. <p>These changes can, but do not have to, lead to an increase in housing benefit.</p> <p>For details, please contact your local housing benefit office.</p>

Verfahrensablauf	<p>Please inform your housing benefit authority of any changes to your financial situation.</p> <p>You can also apply for increased housing benefit at your local housing benefit office. The requirements for this entitlement will be checked.</p>
Bearbeitungsdauer	Housing benefit is increased from the date of application. A retroactive increase in housing benefit is generally not possible.

Hinweise	<p>Changes can, but do not have to, lead to an increase in housing benefit.</p> <p>To ensure that you do not unlawfully claim housing benefit, the housing benefit authority may regularly check the household members by means of a so-called data comparison.</p>
