Volltext	<p>As a German or German national or a national of the European Union who has reached the age of 16 on election day, you are entitled to vote in the electoral area in which you have had your residence, main residence or habitual abode without a residence outside the electoral area since at least the 16th day before the election.</p> <p>You will be entered in the voters' register ex officio as a person entitled to vote if you are entitled to vote on the 42nd day before the election and are not excluded from the right to vote.</p> <p>The voters' register contains the surname, first name, date of birth and details of the home of the person entitled to vote.</p>

**Sachverhalt**

If you have moved in and are registered after the 42nd day but up to the 16th day before the election, you will also be entered in the voters' register ex officio. If this does not happen, you can apply to be entered by the start of the inspection period.

You can inspect the electoral roll on working days from the 20th to the 16th calendar day before the election during the general opening hours of the municipal authority.

**Erforderliche Unterlagen**

- for inspection of own data: none
- in order to inspect the data of other persons, facts must be substantiated from which an inaccuracy or incompleteness of the electoral roll may arise
- for the production of extracts to check the data of other persons, facts must be substantiated from which an inaccuracy or incompleteness of the electoral roll may arise

**Voraussetzungen**

The following requirements apply to the electoral roll for local elections:

- Inspection of your own data: You are entitled to vote
- Access to the data of other persons (not possible for persons with an information block):
  - You are entitled to vote and you have provided credible evidence that the electoral roll is incorrect or incomplete
  - Production of extracts of other persons' data: You are entitled to vote and you have substantiated facts which may result in the inaccuracy or incompleteness of the electoral roll

**Verfahrensablauf**

The procedure is as follows:

- You go to the local authority during general opening hours
- You can inspect the electoral roll with regard to your own data
- You can inspect the electoral roll with regard to the data of other persons if you can provide credible evidence that the electoral roll is incorrect or
