Verfahrensablauf	 Submit an application to the Judicial Examination Office The Judicial Examination Office will check whether you have acquired all the knowledge and skills required to work as a lawyer in Germany during your training If this is the case, your qualification will be recognized If there are any differences, you will have to take an aptitude test The aptitude test consists of a written and an oral part. The written examination consists of two supervised assignments. The oral examination consists of a short presentation and an interview. The Examination Office will issue a confirmation of successful completion of the aptitude test. A failed aptitude test may be repeated twice.
Bearbeitungsdauer	4 Monat(e) The Judicial Examination Office will confirm that your documents have arrived after a maximum of one month. If all the necessary documents have been received, the equivalence check will take a maximum of 4 months. Up to 6 weeks
