Volltext	<p>The tax administration's service portal at <a href="http://www.elster.de">www.elster.de</a> has been set up for the electronic submission of tax returns. It primarily offers citizens as well as companies, associations and organisations the option of submitting their tax returns electronically, but also information on many tax forms. The electronic and, in some cases, already paperless version of the tax return is provided free of charge by the tax authorities. With "ELSTER: Your online tax office" you can deal with many tax matters directly and easily on your PC, smartphone or tablet. In addition to instructions on how to fill out the forms, this includes functions for the paperless transmission of the tax return to the tax office, for calculating the tax due on the declared income and for comparing notices.</p> <p>At <a href="http://www.elster.de">www.elster.de</a> you will also find information on, for example, the income tax return, the trade tax and corporation tax return and also the advance VAT return, the recapitulative statement, the wage tax return, the wage tax certificate and the capital gains tax return. What are the advantages of the electronic income tax return (ELSTER)?

Commercial tax return programs or the free service portal "ELSTER: Your Online Tax Office" of the tax authorities can be used for electronic tax returns. The electronic transmission offers active completion aids as well as functions for tax calculation and assessment adjustment. Under [www.elster.de](http://www.elster.de) you will find all further information on the electronic submission of a tax return.

How does the service portal »ELSTER: Your online tax office« work?

The tax portal »ELSTER: Your online tax office« offers you the possibility of submitting your tax return electronically. This electronic and partly already paperless version of the tax return is provided to you free of charge by the tax authorities. The tax portal »ELSTER: Your online tax office« is an Internet portal solution on which online services of the tax administration are bundled. With "ELSTER: Your online tax office", many tax matters can be dealt with directly and easily on a PC, smartphone or tablet. In addition to the instructions for filling out the forms, this includes functions for the paperless submission of the tax return to the tax office, for the calculation of the tax attributable to the declared income and for the assessment of the comparison. Under [www.elster.de](http://www.elster.de) you will also find further information, e.g. on the income tax return, the trade tax and corporation tax return and also on the advance sales tax return, the recapitulative statement, the wage tax registration, the wage tax certificate and the capital gains tax registration.
