Volltext	Dogs for which the competent authority has determined the dangerousness in individual cases may only be kept with a permit . Permission to keep such a dog must be applied for in writing to the competent authority. Three months after the determination of the dangerousness of a dog in individual cases, the dog owner must submit the documents necessary to check the existence of the permit requirements.
