Volltext	<p>If you would like to work as a tax consultant in Saxony-Anhalt in the future, you will need to be officially appointed by the Saxony-Anhalt Chamber of Tax Consultants.</p> <p>In addition to passing the tax consultant examination or aptitude test (or exemption from the tax consultant examination), your personal suitability will determine whether you are appointed to the position.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Certificate of passing the tax consultant examination or aptitude test or exemption from the tax consultant examination (certified copy) • passport photo • Certificate of good conduct for submission to an authority (§ 30 para. 5 BZRG) - for submission to the Chamber of Tax Consultants • Proof of sufficient professional liability insurance • Form for the declaration of duties • for lawyers, auditors or sworn accountants additionally: Certificate from the professional organization that there are no obstacles to appointment (certificate in accordance with Section 34 (4) sentence 2 DVStB)

	<ul style="list-style-type: none"> • You have passed the tax consultant examination or aptitude test or have been exempted from the tax consultant examination, • you are living in good financial circumstances, • you have not lost the ability to hold public office as a result of a criminal conviction, • you are not engaged in any activity that is incompatible with your profession (e.g. as an employee in another profession or as a tradesman), • you have confirmation of cover from a professional liability insurer (for employees: Proof of inclusion in the employer's liability insurance) • you are not prevented from practicing your profession as a tax consultant for health reasons.

Hinweise	<p>If you would like to work as a tax consultant abroad, please contact the Chamber of Tax Consultants in which you passed your tax consultant examination or aptitude test or were exempted from the examination.</p> <p>Chamber of Tax Consultants:</p> <p>The chambers of tax advisors are corporations under public law. The main tasks of the chamber include, in particular, monitoring the fulfillment of professional duties, representing the professional interests of its members and promoting their further education and training.</p>
Rechtsbehelf	An appeal against the refusal of appointment as a tax consultant is admissible before the tax court.
Kurztext	<p>In order to work as a tax consultant, you must be appointed by the Chamber of Tax Consultants. Appointment as a tax consultant must be applied for in writing using an official form. If all the requirements for appointment are met, a certificate of appointment will be issued. You will also be entered in the professional register.</p>
