Prior to this, the business is regularly given the opportunity to comment on the intended deletion.</p> <p>Membership of the Chamber of Skilled Crafts also expires upon deletion. If a skilled crafts business subject to licensing is deleted from the register of skilled crafts businesses, the skilled crafts card must be returned to the Chamber of Skilled Crafts.</p> |
