Teaser	Do you want to have a say and influence in your municipality, association municipality or district? Read here what options you have.
Volltext	A residents' petition enables the residents of a municipality, an association municipality or a district to have certain matters dealt with by the municipal council, the association municipality council or the district council. Residents' applications may only deal with matters within the municipality's, association municipality's or district's own sphere of influence.
Erforderliche Unterlagen	
Voraussetzungen	Residents must have reached the age of 14 in order to submit a residents' petition. The residents' petition must contain a specific request with a justification. This request must not have been the subject of a residents' petition within the last year. In addition, up to three persons should be named who are authorized to represent the signatories.
Kosten	There are no costs.
Verfahrensablauf	The residents' petition must be submitted in writing with a statement of reasons and the signatures required to support it.
Bearbeitungsdauer	If the residents' petition is admissible, the municipal council, the association council or the district council must discuss it within three months of receiving the petition.
Frist	If the residents' petition is directed against a resolution of the municipal council, the association municipal council, the district council or a decision-making committee, it must be submitted within two months of

Hinweise	Another way of asserting interests at municipal level: A citizens' initiative is a community founded on the basis of a specific cause. It is not bound to any particular legal form. The aim of a citizens' initiative is to influence public opinion, state institutions, parties or other groups. Citizens' petitions and referendums enable citizens to decide directly on important matters relating to the municipality, the association of municipalities or the district. A referendum has the effect of a resolution passed by the municipal council, association council or district council.

Kurztext	The residents' petition is a means by which residents can exert influence. Residents can use a residents' petition to request that the municipal council, the association council or the district council deal with certain matters.
