Volltext	Self-employed persons in particular may suffer a loss of earnings due to quarantine or ban on work incur additional expenses. For example, many self-employed people have to pledge their valuables due to the threat to their livelihood. If you are also affected by this, these additional expenses can be reimbursed to a reasonable extent. This is a so-called "optional benefit". This means that the authorities have leeway to assess whether a claim exists and how high it is.
