Volltext	The "Consultant Engineer" is a protected professional title and certifies special characteristics of its bearer.
	Consulting engineers plan, construct, test, advise and assess, monitor and coordinate the execution of structural systems.
	They are independent of instructions, free of product, commercial and delivery interests and are obliged to represent the interests of their clients. This focus distinguishes them from other service providers in the construction industry.
	If you want to work as a Consulting Engineer, you must apply for entry in the list of Consulting Engineers. The list is maintained by the Chamber of Engineers of Saxony-Anhalt.
	As a consulting engineer, you are automatically also a member of the Saxony-Anhalt Chamber of Engineers. Consulting engineers of the Saxony-Anhalt Chamber of Engineers are affiliated to the pension fund for engineers.
