|                          | In order for your health insurance company to bear the costs of a rehabilitation measure, you must have statutory health insurance. Your health insurance company first checks whether another service provider is primarily responsible.  |
|                          | For employed persons, for example, the pension insurance finances necessary rehabilitation services. Rehabilitation benefits for pensioners, mothers or fathers with children as well as for those in need of care are usually the responsibility of the statutory health insurance. |
|                          | Rehabilitation services must be requested by you. In most cases, the application is made after an acute treatment in the hospital by the social service together with you (follow-up rehabilitation).  |
|                          | Your treating physicians can also encourage medical rehabilitation and issue a doctor's prescription for the application.  |
| Erforderliche Unterlagen | <ul> <li>You must submit an informal application to your health insurance company.</li> <li>Your health insurance company checks whether the requirements for medical rehabilitation are met</li> </ul>  |

|                                 | <ul> <li>and cannot be restored with individual measures, such as physiotherapy and occupational therapy.</li> <li>Rehabilitation ability: You are capable of rehabilitation, i.e. They are resilient to such an extent that necessary treatments can be carried out.</li> <li>Positive rehabilitation prognosis: You can probably achieve individual rehabilitation goals according to a doctor's assessment.</li> </ul>  |
| Kosten                          | <ul> <li>Insured persons who have reached the age of 18 pay a co-payment: 10 euros per day of treatment in outpatient rehabilitation and 10 euros per calendar day in inpatient rehabilitation.</li> <li>The co-payment is calculated for a maximum of 42 calendar days per year. It is paid directly to the rehabilitation facility.</li> <li>In the case of a follow-up rehabilitation immediately after hospital treatment, you must pay for a maximum of 28 days. Co-payments that you have already made within a calendar year for another rehabilitation or inpatient hospital treatment will be credited</li> <li>If you have little or no income, you can be exempted from the co-payment on request. Please contact your health insurance company.</li> </ul> |
| Verfahrensablauf                |  |
| Bearbeitungsdauer               | The health insurance company must decide on applications for rehabilitation services within 2 months.  |
| Frist                           | In principle, you are only entitled to medical rehabilitation again after 4 years. Exception: Rehabilitation can be granted within the four-year period if it is urgently needed for medical reasons.  |

| Rechtsbehelf                    | You can appeal against the decision of the health insurance company. If the objection is not remedied, you can file a complaint with the competent social court.   |

| Kurztext          | The following conditions must be met in order for a medical rehabilitation measure to be approved:  • Need for rehabilitation: performance is impaired and cannot be restored with individual measures, such as physiotherapy and occupational therapy.  • Rehabilitation ability: The patient is capable of rehabilitation, i.e. so resilient that necessary treatments can be carried out.   |
|                   | <ul> <li>Positive rehabilitation prognosis: Patient can probably achieve individual rehabilitation goals according to medical assessment.</li> <li>The health insurance company first checks whether another service provider is primarily responsible. In the case of employed persons, e.B. the pension insurance finances necessary rehabilitation services. As a rule, rehabilitation benefits for pensioners, mothers or fathers with children and for those in need of care are the responsibility of the statutory health insurance.</li> </ul> |
