Volltext	Guide dogs for the blind are specially trained dogs that support blind or severely visually impaired people in everyday life and allow them to orient themselves safely. The statutory health insurance covers the costs for the acquisition, training and training of the dog. She also pays a monthly lump sum for the maintenance costs.

Voraussetzungen	• Severe visual impairment or blindness • Prescription by the ophthalmologist • Species-appropriate accommodation and catering of the dog • personal suitability of the dog owner • daily spout • Holder must have completed mobility training
Kosten	Assumption of the costs for the acquisition, training and training of the dog as well as a monthly lump sum for the maintenance costs by the health insurance.

Bearbeitungsdauer	The health insurance fund must decide on applications for disability compensation within a period of 2 months from receipt of the application.
