Teaser	Would you like to work permanently in Germany as a social pedagogue or social pedagogue? Then you must have your foreign professional qualification recognised.
Volltext	<p>The profession of social pedagogue or social worker is regulated in Germany. This means that you must prove a certain qualification in order to be allowed to work in the profession. If you have a foreign professional qualification as a social pedagogue, you can work in this profession in the selected federal state under certain conditions.</p> <p>To do this, you must submit an application with all the necessary documents to the competent state authority.</p> <p>In the recognition procedure, the body compares your professional qualification from abroad with the professional qualification in the selected federal state and makes an equivalence determination.</p>

You will receive feedback after your application has been reviewed. If your professional qualification is equivalent and you meet the other requirements, you will receive state recognition. Then you may use the professional title "state-approved social pedagogue" or "state-approved social worker".

If you lack professional qualifications for recognition, the notification will state the main differences. You can then make a compensatory measure.

Erforderliche Unterlagen

- Application
- Curriculum vitae
- Proof of identity (identity card or passport)
- Proof of your professional qualification
- Evidence of formal qualifications
- Proof of professional experience as a social pedagogue or social worker
- Proof of other qualifications
- Certificate that the profession may be practised in the country of training
- Information on applications for recognition that have already been submitted. Then indicate to which body you have submitted the application.

You usually hand in these documents later. The competent authority will inform you when to hand in the documents:

- Proof of your personal suitability: for example, extract from the criminal record or certificate of good conduct
- Proof of your medical fitness: medical certificate
- Proof of your German language skills: language certificate

If your documents are not available in German, you must submit German translations of your documents. The translations must be made by translators who are publicly appointed or authorised.

You must submit all necessary documents in the original or in the form of certified copies to the competent authority.</p> <p>The competent authority then checks: Is your professional qualification with the professional qualification in Equivalent to your federal state? For example, the content of the training and the duration of the training are important for the comparison. The competent body shall also take into account your professional experience, other qualifications and qualifications.</p> <p>The competent authority shall then examine the further requirements. If your professional qualification is equivalent and you meet all other requirements, you will receive state recognition. They may then use the professional title "state-approved social pedagogue" or "state-approved social worker".</p> <p>If the competent authority is unable to establish equivalence, you will receive a notification explaining the main differences. 	<p>differences, you can make a compensatory measure.</p> <p>If you successfully complete the compensatory measure and meet the other requirements, you will receive state recognition.</p>
Bearbeitungsdauer	<p>3 Monat(e)</p> <p>The competent body shall acknowledge receipt of your application within one month. The competent authority will inform you if further documents are required. If you have submitted all the required documents, you will receive a notification with the result after 3 months at the latest. In certain cases, the competent body may prolong the procedure.</p>

Rechtsbehelf	<p>You can take legal action against the decision of the competent authority within a certain period of time (for example, file an objection). The decision will then be reviewed. Details can be found in the information on the right of appeal at the end of your decision. We recommend that you first talk to the competent authority before taking legal action against the decision.</p>
