In doing so,</p> <ul style="list-style-type: none"> • the focus is on shared living and integration into society, • the Housing and Care Act apply, • the scope of care largely corresponds to the care in a fully inpatient facility. <p>If you claim a pro rata care allowance for the days on which you are cared for and cared for at home, the days of arrival and departure are considered full days of home care.</p>
