Teaser	If you want to work as a researcher at a German research institution and already have a residence permit from another EU member state for the purpose of research, you can obtain a residence permit under certain conditions
Volltext	You can obtain a residence permit for the purpose of research if you have a residence permit valid for the duration of the procedure from another EU Member State for the purpose of research.
	The residence permit for the purpose of research for mobile researchers is a temporary residence permit. It shall be granted for the duration of the research project, but for a maximum of one year.
	The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up activities in teaching. Changes to the research project during the stay do not lead to the loss of this authorization.
	If the application for the granting of the residence permit is submitted at least 30 days before the start of the stay in the Federal territory and the residence permit of the other Member State is still valid, residence and employment in the Federal territory are considered permitted for up to 180 days from entry within a period of 360 days before your application is

Voraussetzungen	 You have a recognized and valid passport or passport replacement. There is no interest in expulsion against you. You hold a residence permit valid for the duration of the procedure from another EU Member State for the purpose of research under Directive (EU) 2016/801. Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany. You have concluded a hosting agreement or a corresponding contract for the implementation of a research project with a research institution in Germany. You can secure your livelihood and health insurance coverage from your income without using public benefits.
Kosten	Issuance of residence permit for the purpose of research for mobile researchers: EUR 100
	Under certain conditions, a fee reduction or fee exemption may be considered.
Verfahrensablauf	 The residence permit must be applied for at the immigration authority responsible for your place of residence. The procedure is as follows: Depending on the foreigners' registration office and concerns, it may be possible to apply via the Internet. Find out whether your immigration office offers the electronic application for a residence permit. If the application is only possible in person, make an appointment with the Foreigners' Registration Office.

	 During the appointment, your application will be accepted and your proofs will be checked (bring them with you to the appointment). Your fingerprints will be taken for the production of an electronic residence permit (eAT card). In the event of an electronic application, the Foreigners' Registration Office will contact you upon receipt of your online application in order to make an appointment at the Foreigners' Registration Office if necessary. During the appointment, your proofs will be checked (bring them to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT card). If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced. After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office. The eAT card must always be collected in person.
	Fees apply for issuing the residence permit. The timing and form of payment vary depending on the authority. The application can also be submitted to the Federal Office for Migration and Refugees, which will forward your application to the competent immigration authority.

Frist	• Application for a residence permit for the purpose of research for mobile researchers at least eight weeks before the expiry of your still valid residence permit. If you are already in Germany as a researcher as part of short-term mobility, the application must be submitted no later than 30 days before the end of your permitted stay in Germany. • Month of objection: 1 month

Kurztext	 Residence permit for the purpose of gainful employment Granted to mobile researchers Foreigners who hold a valid residence permit from another EU member state in accordance with Directive (EU) 2016/801 for the purpose of research and would like to work at a German research institution for more than 180 but no more than one year can obtain the residence permit for mobile researchers. The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up activities in teaching. The residence permit for mobile researchers is a temporary residence permit. It shall be granted for the duration of the research project, but for a maximum of one year. If the application for the granting of the residence permit is submitted at least 30 days before the start of the stay in the Federal territory and the residence permit of the other Member State is still valid, residence and employment in the Federal territory are considered permitted for up to 180 days from entry within a period of 360 days before a decision is taken on the application. Spouses of holders of mobile researchers are also entitled to a residence permit. Depending on the immigration office and concerns, the application is possible via the Internet or in person.
