	 Children, adolescents or young adults who live in a foster family or in an inpatient child and youth welfare institution ("children's home"). Children and young people who have been taken into care by the Youth Welfare Office (provisionally), young people who live in a form of housing accompanied by socio-pedagogical supervision during their participation in school or vocational training or during vocational integration. Mothers or fathers who alone care for a child under the age of six and live with the child in a common form of housing for mothers/fathers/children Children who live with their mother or father in a common form of housing for mothers/fathers and children

	 Health assistance is only granted if there is no other health insurance cover or if it does not fully cover the necessary needs. The person entitled to custody or the child or the adolescent or the young adult are entitled.
Kosten	There are no fees.
Verfahrensablauf	 The responsible youth welfare office checks whether health insurance cover exists elsewhere, for example through family insurance or voluntary continued insurance. If there is no priority option of health care or health insurance, the Youth Welfare Office ensures health care (for example, by registering with a statutory health insurance company).

Frist	There are no deadlines to be observed.
