Teaser	For the construction and operation of warehouses in which explosive substances are to be stored or for significant changes to these warehouses, you require a permit in accordance with the Explosives Act.
Volltext	Explosive substances have a great potential for danger. The aim of the Explosives Act (SprengG) is to protect people and property from these dangers. Against this background, you generally require a storage permit in accordance with the Explosives Act for the storage of explosive substances. Significant changes to an approved storage facility or significant changes to its operation also require a permit. If you store a net explosive mass of 10 tons or more, you need a permit in accordance with § 4 of the Federal Immission Control Act (BImSchG). The permit according to BImSchG is then also valid as a permit according to the Explosives Act. A storage permit may not be required if the "small quantities" specified in the Second Ordinance to the Explosives Act (2. SprengV) are not exceeded.
Erforderliche Unterlagen	Informal • Details of the company, address and contact person at the company • Field map with marked storage site • Information on type and quantity of explosive substances (BAM group, storage group, compatibility group) • Construction description, construction documents, construction method

	• if applicable, copy of the permit according to §7 or § 27 SprengG for handling explosive substances • If applicable, type approval • if applicable, concept for the prevention of incidents with safety management • If applicable, fire protection concept in accordance with industrial construction guidelines with floor plan and location of safety equipment (such as extinguishing equipment) • If applicable, expert opinion at the request of the authorities
Voraussetzungen	As an operator, you must be in possession of a valid permit for the acquisition and handling of explosive substances
Kosten	Costs are charged by each state according to its own fee ordinance.
Verfahrensablauf	• As this is a complex procedure, it is recommended to contact the responsible person before submitting the application. • Submitting an application and attachments to the responsible authority. • Checking the application for completeness and plausibility and, if necessary, requesting missing documents. • As a rule, an on-site appointment is arranged. • On-site inspection and, if necessary, request for additional documents. • Notification of the decision and request for payment. • The number of application records is to be agreed with the clerk.
