Teaser	The written appointment of a responsible person must be reported to the competent authority. The person must have a valid certificate of competence for handling explosives.
Volltext	As the owner of a company that is permitted to handle or trade in explosive substances, you must appoint a responsible person in writing. The name, address and date of birth of the responsible person appointed in writing must be notified to the competent authority without delay. The responsible persons to be considered are defined. The expiry of an appointment must also be reported.

Voraussetzungen	The person appointed in writing must be in possession of a valid official certificate of competence. A certificate of competence is a permit to work with explosives.
