Teaser	If you are severely disabled, you are entitled under certain conditions to free transport in local public transport or to a reduction in vehicle tax.
Volltext	<p>If you have a two-colour severely disabled person's pass on which certain marks are indicated, you can use this application to apply for a supplement and a token.</p> <p>This allows them to benefit either from free local passenger transport or from a reduction in vehicle tax.</p> <p>In order to be able to use free transport in local public transport, you must purchase a token for half a year or a whole year against payment of a deductible. The personal contribution does not apply if certain characteristics are available or certain social benefits are received.</p> <p>Alternatively, you can apply for a supplement without a token instead in order to receive a reduction in road tax.</p> <p>For persons with certain marks, there is the possibility</p>

	<p>to take advantage of both the reduction of the motor vehicle tax and free transport in public transport with the supplement with token.</p> <p>If your supplement is damaged or you have lost it, you can request a replacement issue.</p>

The amount of the own contribution is currently 46 € for half a year and 91 € for a whole year. You will receive the token without excess if you have been awarded at least one of the marks Bl or H or if you receive certain social benefits as a severely disabled person.</p>
Verfahrensablauf	<p>After you have submitted the application, your documents will be checked for eligibility on a supplementary sheet.</p> <p>If you meet the requirements, the fee you have to pay will be determined and a remittance slip will be sent to you.</p> <p>The supplement with token will be sent to you after payment.</p> <p>If you meet the requirements for a supplement with a token without excess, the supplement with token will be sent to you immediately.</p> <p>If you do not meet the requirements, you will receive a</p>
