Teaser	If you wish to check, test, maintain or repair X-ray equipment or interference sources on a commercial basis, you must notify the competent authority before starting the activity.
Volltext	Do you intend to inspect, test, maintain or repair X-ray equipment or interference emitters on a commercial basis? In these cases, you must notify the competent authority in writing before starting the activity.
	If the competent authority does not prohibit your planned activity, you can start the activity. A prohibition can be made if:
	 there are facts that give rise to doubts about the reliability of the person obliged to file the complaint, Required evidence is not or no longer fulfilled or is no longer fulfilled or there are facts that give rise to doubts as to the availability of the personnel necessary to carry out the activity.
Erforderliche Unterlagen	 Written appointment of the radiation protection officer(s) by the radiation protection officer or officers, stating the internal decision-making area. Proof of expertise (and, if necessary, updating) in radiation protection for the radiation protection officer. Voraussetzungen	The requirements are met if:
	1\. The written appointment of the radiation protection officer by the radiation protection officer has been received, stating the internal decision-making area of the radiation protection officer in the applicant's company.
	2\. Proof of the expertise of the radiation protection officer(s) or the radiation protection officer or persons responsible for radiation protection in radiation protection is available by presenting a certificate of expertise (expert knowledge group R5.1 / R5.2 or R6.1 / R6.2).
	3\. Proof of the existing equipment and the measures required by the state of the art to ensure compliance with the protective regulations have been provided.
	4\. Apart from that, there must be no facts that give rise to doubts about the reliability of the person obliged to report. Furthermore, there must be no facts that give rise to concerns about the safe execution of the activities due to a lack of necessary personnel

Verfahrensablauf	 Before commencing an activity (inspection, testing, maintenance, repair), all necessary evidence must be available from the competent authority. You can submit the evidence by post to the competent authority with the notification. If the competent authority does not object to the evidence you have submitted, you can start the activity.
