Teaser	Would you like to work in Germany as a medical technologist for veterinary medicine? Then you need a state permit. For this purpose, you can have your foreign professional qualification recognized.
Volltext	The profession of Medical Technologist for Veterinary Medicine or Medical Technologist for Veterinary Medicine is regulated in Germany. This means that in order to be able to work as a medical technologist for veterinary medicine in Germany, you need a state permit. With the permit, you are allowed to use the

professional title "Medical Technologist for Veterinary Medicine" or "Medical Technologist for Veterinary Medicine" and work in the profession.

Even with a professional qualification from a so-called third country, you can obtain state permission from the competent authority in Germany. Third countries are all countries that do not belong to the European Union (EU), the European Economic Area (EEA) or Switzerland.

In order to obtain the permit, you must have your foreign professional qualification recognized.

In the recognition procedure, the competent authority compares your professional qualification from abroad with the German professional qualification and checks its equivalence. The equivalence of the professional qualification is an important prerequisite for the issuance of the state permit.

In addition to the equivalence of the professional qualification, you must meet other requirements for the granting of the permit. Other requirements are, for example, sufficient German language skills and health suitability. If your professional qualification comes from the EU, EEA or Switzerland, different regulations apply. You can also apply for the procedure from abroad.

## Erforderliche Unterlagen

- Proof of identity (ID card or passport)
- Marriage certificate (if your name has changed due to marriage)
- Curriculum vitae
- Proof of your professional qualification (e.g. certificates, professional certificate)
- Proof of training
- Proof of your relevant professional experience as a Medical Technologist for Veterinary Medicine or Medical Technologist for Veterinary Medicine
- Proof of further relevant knowledge for working as a medical technologist for veterinary medicine or medical technologist for veterinary medicine
- Declaration that you have not yet submitted an application for recognition

• Perhaps: You come from a third country and do not yet live or work in the EU, the EEA or Switzerland? Then you have to prove that you want to work in the profession in Germany. Proof includes, for example, an application for an entry visa for gainful employment, applications for a job, invitations to job interviews, a business concept or a location note from the Central Service Agency for Professional Recognition (ZSBA).

You usually hand in these documents later. The competent authority will inform you when you should hand in the documents:

- Proof of your personal suitability: for example, an extract from your criminal record or certificate of good conduct from your country of origin
- Proof of your health suitability: for example, a medical certificate
- Proof of your German language skills

The competent authority will tell you which documents you need to submit as a simple copy, as a certified copy or in the original.

## Voraussetzungen

- You have a professional qualification as a medical technologist for veterinary medicine or medical technologist for veterinary medicine from a third country.
- You want to work in Germany as a medical technologist for veterinary medicine or medical technologist for veterinary medicine.
- Personal aptitude: You are reliable to work as a Veterinary Medical Technologist or Veterinary Technologist and have no criminal record.
- Health aptitude: You can work mentally and physically as a Medical Technologist in Veterinary Medicine or Medical Technologist in Veterinary Medicine.
- You have German language skills at the required language level. This is usually the language level B2 according to the Common European Framework of Reference for Languages (CEFR).

## Kosten

The costs generally depend on the effort required for processing.

In addition, additional costs may arise (e.g. for translations, certifications or compensatory measures). These costs vary from person to person.

## Verfahrensablauf

### Application

You submit an application for permission to use the professional title "Medical Technologist for Veterinary Medicine" or "Medical Technologist for Veterinary Medicine" to the competent authority. You can submit the application with the documents to the competent authority or send it by post. Do not send originals. Sometimes you can also send the application electronically.

### Examination of equivalence

The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent authority compares your professional qualification from abroad with the German professional qualification as a medical technologist for veterinary medicine. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.

### Possible results of the test

If your professional qualification is equivalent, your foreign professional qualification will be recognised. The competent authority can confirm the result to you in writing. You still have to meet the other requirements. Then you will receive permission to use the professional title "Medical Technologist for Veterinary Medicine" or "Medical Technologist for Veterinary Medicine".

Are there any significant differences between your professional qualification and the German professional qualification? Perhaps you can compensate for the differences through your professional practice, other knowledge or skills (lifelong learning). You must prove that you have professional experience. Knowledge and

skills must be certified by an authority of the state in which you acquired the knowledge or skills.

However, it may be that the essential differences cannot be compensated for by this knowledge. In this case, the competent authority will tell you the main differences between your professional qualification and the German professional qualification. It also tells you why you can't make up for these key differences.

The competent authority will also provide you with compensatory measures that you can take to compensate for the significant differences.

If you decide not to take compensatory measures, your professional qualification will not be recognised. You are then not allowed to work in Germany as a medical technologist for veterinary medicine or medical technologist for veterinary medicine.

### Compensatory measures

There are various compensatory measures:

- Adaptation period: The adaptation period lasts a maximum of three years.
- Knowledge test: The knowledge test tests your knowledge in specific subjects and areas. The knowledge test consists of an oral and a practical part.

As a rule, you can choose between an adaptation period or a knowledge test.

If you successfully complete the compensatory measure and meet all other requirements, you will receive permission to use the professional title "Medical Technologist for Veterinary Medicine" or "Medical Technologist for Veterinary Medicine".

After a maximum of one month, the competent authority will confirm that your application and documents have arrived. The competent authority will inform you if documents are missing. If the documents are complete, the procedure will take a maximum of 3

Frist	Sometimes documents are still missing in the procedure. The competent authority will then inform you by when you have to submit the documents.

Hinweise	<p>Notice of equivalence</p> <p>In the approval procedure, the equivalence is also checked (recognition procedure). You can apply for a separate notification for the result of the examination.</p> <p>Procedure for ethnic German repatriates</p> <p>As a late repatriate, you can go through the recognition procedure either according to the laws mentioned here or according to the Federal Expellees Act. You can decide for yourself. The competent authority will advise you on which procedure is right for you.</p>
