Teaser	If you want to hold an event at your airfield where aircraft are displayed in flight or compete against each other in a competition, then you need a permit. You must apply for this from the relevant aviation authority.
Volltext	Aviation events are associated with particular hazards due to the increased traffic density and a large number of visitors. They must therefore be meticulously planned, meticulously executed and strictly controlled. The responsible aviation authority checks whether the program and the participants offer the guarantee that the event will be held safely and, in the case of event approval, regulates necessary safety and noise protection precautions.
	During the event, the aviation authority monitors

	You do not need a permit for aviation events in which only model aircraft and non-motorized aerial sports equipment participate under an already issued ascent permit, which are not subject to mandatory traffic licensing and with which no passengers are transported.
Erforderliche Unterlagen	 Completed application for approval of an aviation event Consent of the aerodrome operator (unless the event organizer is also the aerodrome operator). Aerial event located outside of an aerodrome: Proof of right of use Sketch of the site envisaged, indicating its dimensions, and an expert opinion on its suitability Map on a scale of 1:25000 Site plan at a scale of 1:1500 to 1:5000 with the event site marked. The dimensions of the event site, take-off and landing areas, the locations of the emergency services and the doctor as well as parking spaces and the barriers must be drawn in the plan. Program of the event including flight program Air traffic control information (description of the airspace or routing required for the air show). At the request of the competent authority: Safety concept including emergency planning Flight operation instructions of the person in charge of the event Agreements of the event organizer with the pilots, air carriers, other parties involved in the air and ground demonstrations and with the liability and accident insurance Proof of ground accident insurance Proof of ground accident insurance Proof of pliots Expert opinion on the suitability of the event site
Voraussetzungen	 As the organizer, you have taken out organizer's liability insurance to cover any third-party damage. The aviation event does not endanger public safety or order.

Verfahrensablauf	You can apply for approval of an event with aircraft by mail:
	 Submit all required documents with your application. The responsible office will conduct a review of your application.
	 It will be checked whether the program and the participants ensure that the event can be held safely. After reviewing the documents, the competent body will decide whether you will receive a permit to hold the aerial event. You will receive a notice of approval or rejection (by mail or, if necessary, via the service portal of the competent body). In the case of event approval, the competent body will regulate necessary safety and noise protection measures.
	During the event, the competent body monitors compliance with these requirements.
