Volltext	If you want to practice falconry in Germany, you need a German falconry hunting license in your name. If you are already in possession of a hunting license but its validity has expired, you can apply for an extension.

If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority. The application and the evidence to be submitted will be checked for completeness and correctness. If you meet all the requirements, you will be issued a falconry hunting license.
