Volltext	If you would like to practice falconry in Germany, but you are not yet 18 years old, you can only be issued a Jugendfalknerjagdschein in your name.

	If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority. The application and the evidence to be submitted will be checked for completeness and correctness. If you meet all requirements, you will be issued a youth falconry hunting license.

Frist	The annual hunting license is valid for a maximum of two consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03..

Hinweise	• With a falconer's hunting license, you may only hunt in the company of a custodian with hunting experience or a supervisor with hunting experience appointed in writing by your custodian(s). • With a falconer hunting license you are not allowed to participate in social hunts.
