Volltext	If you would like to practice falconry in Germany, but you are not yet 18 years old, you can only be issued a youth falconry hunting license in your name If you are already in possession of an annual hunting license, but its validity has expired, you can apply for an extension.

Verfahrensablauf	You can submit the application in writing or online, if available. If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority.

	The application and the evidence to be submitted will be checked for completeness and correctness. If you meet all requirements, you will be issued a youth falconry hunting license.

Frist	The youth falconry hunting license is valid for a maximum of two consecutive hunting years. A hunting year begins on 01.04. and ends on 31.03. of each year.

Hinweise	• The youth hunting license entitles you to hunt only in the company of a custodial person or a supervisor appointed in writing by the custodial person. The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in social hunts.

Kurztext	• Youth falconer hunting license New issuance of annual hunting license • required for falconry in Germany • Persons who already own or have owned a German falconry hunting license • for persons under 18 years, minimum age 16 years • Possession of a hunting license or special hunting license for falconers is required • hunting is only allowed if accompanied by a parent or guardian with hunting experience or an authorized representative • no participation in social hunts • annual hunting license is valid for a maximum of two consecutive hunting years • hunting year begins on 01.04. and ends on 31.03. • responsible: lower hunting authority
