Volltext	If you wish to hunt in Germany, but you are not yet 18 years old, you can only be issued a youth hunting license in your name. If you already have a hunting license but its validity has expired, you can apply for an extension.

Frist	The day hunting license is valid for 14 consecutive days.

Hinweise	The youth hunting license only entitles the holder to hunt in the company of a custodial person or a supervisor appointed in writing by the custodial person; the accompanying person must be experienced in hunting. The youth hunting license does not entitle the holder to participate in social hunts.
